## **Show Rules**

- 1. This is an official ARBA sanctioned show and will be governed by the latest revised rules of that body. Completed entry indicates acceptance of same and additional rules.
- 2. All open rabbits will be judged by PRIVATE EAR NUMBER
- 3. Carrying cages must have solid bottoms. Exhibitors are responsible for getting their animals to and from the table when called.
- 4. Diseased stock will be removed from the showroom and entry fee will be forfeited. 5. RB&FCD reserves the right to substitute, add or decline judges based on number of entries, and adjust breed order when needed
- 6. Every precaution will be taken to ensure safety and prevent loss, but RB&FCD will not be responsible in case of fire, theft, accident or property destruction.
- 7. Anyone causing a disturbance or trying to intimidate a judge will be asked to leave the showroom and their entry fee forfeited.
- 8. No individuals will be allowed behind the judging tables unless approved by show committee.
- 9. Any costs incurred by RB&FCD by checks that fail to clear the bank will be passed on to the exhibitor.
- 10. Ribbons will be awarded through 3rd place in all classes. Ribbons and any other awards must be picked up at the Secretary's table.
- 11. If there are less than 5 entries in the breed, there will be no award.
- 12. RB&FCD believes all specials donated by individuals are bona fide offers, but RB&FCD cannot guarantee them.
- 13. Children must be in the care of an adult to ensure they don't upset the animals or members of the show committee.
- 14. No alcoholic beverages or smoking will be allowed in the showroom.
- 15. There will be a designated area for grooming tables.
- 16. Youth sanctioned breeds will be noted by an (\*). Youth entries will be shown and handled by a youth.
- 17. No vendor may set up without permission from the Show Superintendent REMARK CARDS WILL NOT BE USED but will be available for your use at the secretary table. It is the exhibitor's responsibility to complete your card.
