General Show Rules


1. The COVID Conquest Committee(s) reserves the right to restrict show entries due to COVID-19 or RHDV2 limitations
2. This is an official ARBA sanctioned show and is governed by the latest rules as such
3. Any animal showing signs of sickness or disease will be removed from the show room at the discretion of the Superintendents and entry fee will be forfeited
4. The superintendents reserves the right to substitute judges if necessary
5. All rabbits must have a permanent and legible earmark
6. Judging will conducted by private ear number
7. Exhibitors will be responsible for carrying their own rabbits to and from the judging table
8. **To avoid delays – the three call rule will apply... at the judge's discretion.**
9. Neither 4-H Acres or NCRCBA or other affiliated clubs will not be responsible in case of fire, theft, accident or providential destruction, however, precautions will be taken to reduce any risks
10. Children must be supervised at all times
11. No exhibitor or spectator will be permitted behind the show tables while judging is being conducted, without prior approval of the Superintendent(s) and Show Secretary(s)
12. The showroom will be open at 7 AM
13. All entries must be in the showroom by 8:30AM. **Judging will start promptly at 9AM.**
14. Exhibitors must pick up check-in sheets and verify entry
15. NO CHANGES DONE AT JUDGES TABLE unless approved by show secretary
16. This is a carrying cage show. All carriers must have leak proof bottoms
17. Grooming tables, chairs, and blowers will only be allowed in the showroom if there is room
18. ABSOLUTELY NO dogs, cats, or animals other than rabbits will be allowed in the showroom
19. Anyone causing a disturbance or trying to intimidate a judge will be asked to leave and their entry fee will be forfeited
20. There will be No Breeding Allowed in the Showroom
21. **Remark cards WILL NOT be prepared or provided.** If you'd like to use remark cards for your entry you must bring your own and fill them out for the writers.
22. All returned checks will be charged a \$25.00 fee the first and second time they are deposited
23. All show reports will be sent to exhibitor via e-mail (when applicable).

COVID-19 Show Rules

1. Exhibitors are asked to please limit or not bring extra people to the show
2. Social Distancing will be enforced
3. All current NY guidelines will be followed
4. Masks are required when not seated. Each exhibitor will receive one warning, after that you will be disqualified from competition, asked to leave the show and grounds, and entry fees will be forfeited
5. We ask that anyone from hot spots not attend
6. Entries will not be accepted from any exhibitor in a “hot spot” state
7. Check with NY restricted states

8. Grooming tables & chairs will have designated areas allowing for more open space
10. Animals will be placed in table top cooping and locked in while the judge evaluates allowing for exhibitors to distance from the tables
11. Further guidelines will be available as the show gets closer and we have updated guidelines
12. The COVID Conquest show committee(s) are dedicated to making this a fun & safe show for all
13. Hand sanitizer will be provided at each show table

RHV/VHD/RCV Show Rules

1. The Show will follow all guidance put out by the ARBA
2. No entries will be taken from anywhere within 150miles from an outbreak



The COVID Conquest Specialty show is on the same day as the written exam for the MARCS-hosted Youth Royalty competition (this is in conjunction with the 2020 Virtual ARBA Convention). The Tompkins County 4-H Bunny FooFos rabbit club has graciously rented a building with wi-fi available on the premise for youth to take their exam. Note – each youth must already be registered through MARCS to take this exam – you cannot register day of the show.

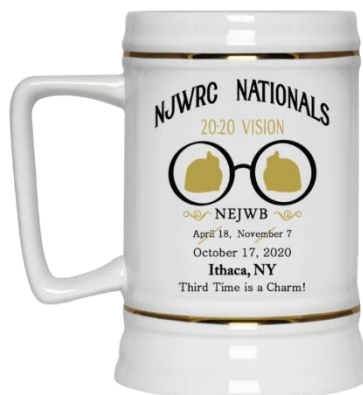
