## SHOW RULES

1. All entries are entered and shown at the risk of the owner. T.A.R.B.A. will not be responsible in case of fire, theft, accident or providential destruction. However, every precaution will be taken to eliminate danger.
2. T.A.R.B.A. reserved the right to substitute a judge or judges at any time it deems necessary.
3. All entries must have a legible permanent tattoo in the left ear.
4. Any animal showing signs of sickness or disease will be removed from the showroom.
5. This is a carrying case show. NO express shipments will be accepted. NO telephone entries will be accepted. All carrying cages MUST have leak proof bottoms. ANY cage found leaking will be removed from the show room.
6. Absolutely NO breeding of stock in the show room.
7. Absolutely **NO DOGS ALLOWED** in the show room.
8. All exhibitors are responsible for getting their animals to the show table promptly. There will be NO more than three (3) calls for a class. After that, any animal not on the table will be disqualified.
9. Payment for entry fees must accompany the entry form and will mean that the exhibitor will comply with all A.R.B.A. rules and those rules set forth in this catalog.
10. ANY exhibitor whose check for entry fees fails to clear the bank will have their name left off of both the State & any National Breed Club report & will be considered as never having entered. Violators will be prosecuted to the fullest extent of the law and must pay any bank fees incurred. We reserve the right to reject any entry as per ARBA rules.
11. Judging starts promptly at 9:00 a.m. We request that exhibitors be ready at this time.
12. ALL PRIZES must be picked up before leaving the show.
13. All private-paid late specials will be posted in the show room and will be given in addition to those in this catalog. Those in the form of ribbons or rosettes must be picked up by the end of the show. T.A.R.B.A. cannot be held responsible for "private paid" specials not paid by T.A.R.B.A.
14. CHILDREN MUST BE UNDER PARENTAL CONTROL AT ALL TIMES, otherwise both will be asked to leave the show and entry money will be forfeited.

## RHD Rules

1. The Show will follow all guidance put out by the ARBA (visit [arba.net](http://arba.net) for details).

## Covid & Social Distancing Mandates

1. Social Distancing will be enforced.
2. PROPER placement of Masks are required as per NYS Mandates.
3. No day of show entries will be accepted (except by pre-entered exhibitors) to help us plan best for required spacing mandates.
4. Exhibitors are asked to please limit or not bring extra people to the show.
5. Grooming tables & chairs will have a designated area, allowing for more open space.
6. When animals are being evaluated, they will be placed in table top cooping and exhibitors will step back 6 feet. Judge may ask 1 or 2 exhibitors to step forward if assistance with animals is needed.
7. Additional guidelines may be available as the show gets closer and we receive updated guidelines.
8. Exhibitors & ALL those attending **MUST** Sign the TARBA Liability Waiver; this will serve as our contact & trace verification.
9. Exhibitors should plan to bring a pop-up tent for shelter as exhibitors will NOT be permitted in the building until it is their turn to show.
10. TARBA is committed to making this a fun & safe show for all. Those not abiding with required mandates WILL be asked to leave & will forfeit their entries & entry fees.

Take the Exit 12 (Homer) off-ramp to Route 11 South.

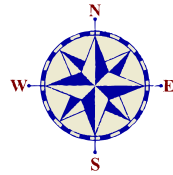
Take a right on to Carrell St.
