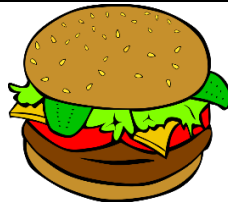

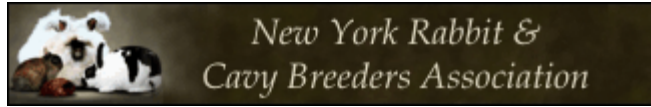

Show Rules:

1. This is an Official ARBA Sanctioned Show and will be governed by the latest revised show rules of that body. The completion of the Entry Blank indicates acceptance of these rules and regulations.
2. This is an official NYR & CBA Show. Points to count towards sweeps prizes. To be eligible for these prizes, you must be a member in good standing of a local all-breed association and show in at least 40% of the NYR&CBA sanctioned shows.
3. This is a carrying case show. All carriers must have leak - proof pans.
4. Day of Show Entry is \$6.00. Pre-entry Fee is \$ 4.00 per rabbit and \$ 1.00 for fur class. Any rabbit entered in fur class must be entered in their open class.
5. A youth exhibitor may show in both youth and open, but they may not show the same animal. However, they may show the same animal in any of the specialty shows. Youth must carry the youth rabbits and Cavies to and from the judging table. Youth will be judged at the same breed table as open.
6. Owners of animals showing signs of contagious disease will be asked to remove them from the showroom. Non-compliant entry holders will be completely forfeited from the show and reported to ARBA.
7. All exhibitors are responsible for getting their own animals to and from the judging table. The 3-call rule will be enforced.
8. All animals must be in the show room no later than 8:45 am. Judging will start promptly at 9 am. All exhibitors are responsible for getting their animals to and from the judging table. No refunds for animals not shown.
9. ECRCB reserves the right to add or substitute judges as needed.
10. There must be 10 or more rabbits shown in a breed in 2023 to be sanctioned at the 2024 show by the ECRCB
11. All animals must be permanently ear marked or tagged legibly. Cavies must have the coop #'s on adhesive tape or forfeit the fee.
13. The ECRCB, Inc. will not be responsible in case of fire, theft, accident or providential destruction. Every precaution will be taken to eliminate any danger or mishap in the showroom.
14. No alcoholic beverages or ANIMALS other than rabbits/cavies allowed in the Showroom. Example: **NO DOGS, CATS or BIRDS etc.**
15. We ask Canadian Exhibitors to please pay in US cash.
16. Parents will be held responsible for their children.
17. Any exhibitor issuing a bad check will be charged a collection fee as charged by the bank. All offenders will be reported to the NYR& CBA and ARBA and their sweepstakes points will not be awarded until the debt is settled.
18. Breeds must have 10 or more entered to be eligible for stated awards offered by ECRCB. ECRCB will not be responsible for specials donated by individuals. Awards will be available after 10 am. No trophies, ribbons, or rosettes will be mailed.
19. Any event or circumstance that occurs which is not covered by these rules, will be subject to the decision of the Show Committee and such decision will be final.
20. **Absolutely no breeding of animals in the showroom**
21. Children under 5 must show their rabbits or cavies in open
22. **Bounced checks will be assessed a \$25.00 fee from the Club, anyone entering the show that does not show up, still has to pay and will be sent a bill. Once judges are hired payment to them still has to happen. We cannot absorb that cost. Failure to pay will result in you being reported to NYRCBA and ARBA.**

1. CAMPER shall defend, indemnify, and hold harmless OCCCE, its employees, officers, volunteers, and directors from any and all claims, actions, demands, or other proceedings for any actual or alleged injury to persons or damage to property arising out of any act or omission of the CAMPER, its employees, guests, or invitees during its use or occupancy of the premises.
2. CAMPER agrees to leave premises in the condition in which they were upon arrival.
3. CAMPER agrees to the following :
 - a. No open fires
 - b. No excavations
 - c. Parking in specified areas only
 - d. To use outdoor grills only in the designated area.
 - e. No alcohol or controlled substances.
 - f. Rabies shots will be required for all animals which are brought.
 - g. No bulk water, only bottled water permitted.
 - h. No human waste or wastewater is to be discharged on the grounds. Wastewater is to be dumped at restroom holding tank only. Violators will be subject to a maximum \$500 fine.
 - i. All campers must be at least 10 feet from the next camper.
4. OCCCE reserves the right to expel any individual or group of individuals that may damage the facilities.
