### Registration Info:

1. Entry Deadline: All entries are due by April 16, 2024 @11:59 p.m. EST through the Easy2Show Program ([easy2show.com](https://easy2show.com)) or can be sent via email by April 12th @11:59 p.m. No text, Facebook, snail mail, or phone entries are accepted. Pre-entries are a promise to pay whether you attend or not.
2. Entry Fees posted above. Failure to meet the above pre-entry deadline, will be considered a "day-of-show" entry and the "day-of-show" entry fee will apply.
3. Entries can be paid either via cash, check, or PayPal (cattcorba@gmail.com). Returned checks will be charged a \$35 return fee.
4. It is highly encouraged to enter via [Easy2Show](https://easy2show.com), but if you cannot use that program, please send your entries to Rebecca Sprague cattcorba@gmail.com.
5. All RHD/RCD/VHD guidelines will be followed. CCRBA reserves the right to refuse entries from all locations within the current parameters set by the ARBA and USDA.

# SHOW RULES & INFORMATION:

1. This show will be governed by the latest rules of the ARBA. Your entry indicates your acceptance of these rules.
2. The showroom will open at 7 a.m. on Saturday and judging will begin at **9:00 a.m.**
3. **All help with the show would be greatly appreciated, including set up and take down.**
4. All rabbits must have a permanent & legible tattoo in the left ear.
5. This is a carrying cage show. Leakproof bottoms are required, and cages must be secure.
6. Any animals displaying signs of sickness, as verified, disqualified by a judge for sickness at the time of judging must be removed from the showroom immediately.
7. Out of consideration for the judges & clerks, please trim your rabbit's toenails before the show.
8. CCRBA reserves the right to add, substitute or cancel judges. Judges decision will be final. Interfering with the judging will not be tolerated. The final interpretation of the show rules is the responsibility of the show committee.
9. There will be NO changes made at the judges table without approval from the Show Secretary.
10. Remark cards WILL NOT be prepared or provided. If you'd like to use remark cards for your entry you must bring your own and fill them out for the writers.
11. Breeders are encouraged to volunteer as table help during the judging of their breeds. With the exception of the judge and clerk, no one will be allowed behind the tables during judging.
12. Each person is responsible for getting their rabbits to the judging table - youth must put youth rabbits on the table. The "Three Call" Rule will be enforced.
13. With the exception of service animals, no other animals, except rabbits, are permitted in the showroom.
